The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school. For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

Important Notes: 1. The total number of sections shall be restricted to 24 sections (as per prescribed dimensions) according to classrooms reported on inspection and further increase shall be subjected to specific approval of the Board as per affiliation Byelaws.

- 2. The School is required to display the name of the School at the Gate and submit the compliance on the saras portal within 3months.
- 3. The school has overlaid a ramp on the staircase, as a result, it is very steep, un revigable and dangerous for CWSN. The school shall pull it down and construct a ramp with proper incline, as prescribed in the RPwD Act and submit compliance on SARAS within 3 months.
- 4. The School is required to appoint Special Educator as per Board norms and submit the compliance on the saras portal within 3 months.
- 5. The RC has pointed to the need of more reference books in the library and more outdoor sports facilities. The school shall upgrade these facilities in the light of SoPs issued by the Board and submnit compliance within 3 months on SARAS.
- 6. The school shall follow the SoPs issued by the Board in respect of labs, library and ports facilities.
- 7. The School shall ensure training of its teachers with CoE Ajmer and submit compliance within 3 months on SARAS.
- 8. The School is directed to renew all the mandatory certificates from time to time and directed not to remove the videography link in future.

The total number of section of the school shall be restricted to 72 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation by elaws.				
2.	Compliance of the points no. 1 to 9 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

1	The lessor details, period of lease and schedule of land are not mentioned in the Land certificate. The school has uploaded the lease agreement on the mandatory public disclosure. The school should upload the revised Land certificate with the complete details in Appendix X format. on the SARAS portal within 3 months.				
2	The sign of issuing authority is missing in Building safety certificate and blocks are not mentioned. The school is required to upload the Building Safety certificate mentioning the number of blocks with sign of issuing authority and submit the compliance within 3 months on SARAS portal.				
3	Computer lab is undersized and understocked. The school should shift the computer lab to bigger room as per board norms and procure more computers to maintain 1:18 computer to students ratio as per Circular no. 10 dated 24.03.2023 and submit the compliance through videography within 3 months on SARAS portal.				
4	Chemistry, Physics and Biology labs have no seating arrangements and are understocked. The school should upgrade the labs in the light of SoPs laid down for labs, library and sports activities vide the board Circular no. 11 dated 04.10.2022 and submit the compliance through videography within 3 months on SARAS portal.				
5	There are no proper Signage in all labs and library. The school should fix permanent signages at the entrance of the rooms and submit the compliance within 3 months on SARAS portal.				
6	Two CWSN washrooms were seen in the video. The school should construct the CWSN toilets separately for boys and girls on every floor and all blocks and submit the compliance through videography within 3 months on SARAS portal.				
7	Peeling paint is seen in many rooms. The school should maintain the ambience of the building and the campus and submit the compliance within 3 months on SARAS portal.				
8	The school should appoint teachers and maintain 1.5 teachers per section, excluding Principal, Physical Education teacher and Counsellor, to teach various subjects and submit the compliance within 3 months on SARAS portal.				
9	The school should ensure training of teachers with CoE Ajmer and submit the compliance.
